

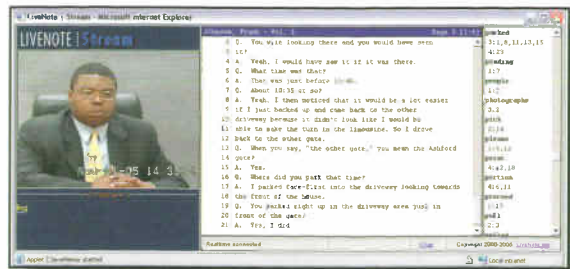
Realtime transcripts and video

 - Live video of the deponent



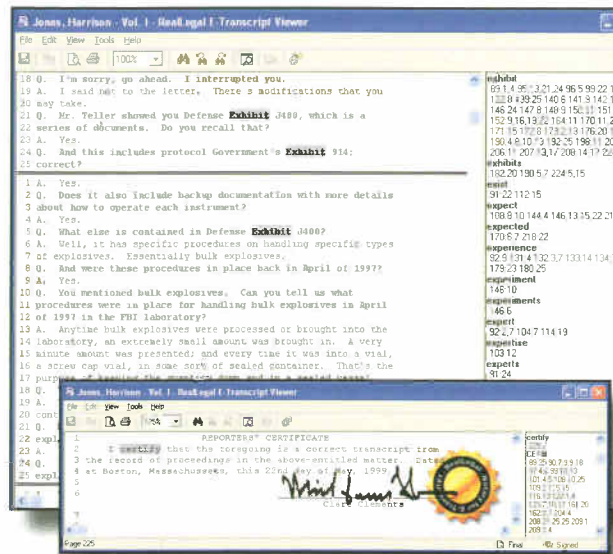

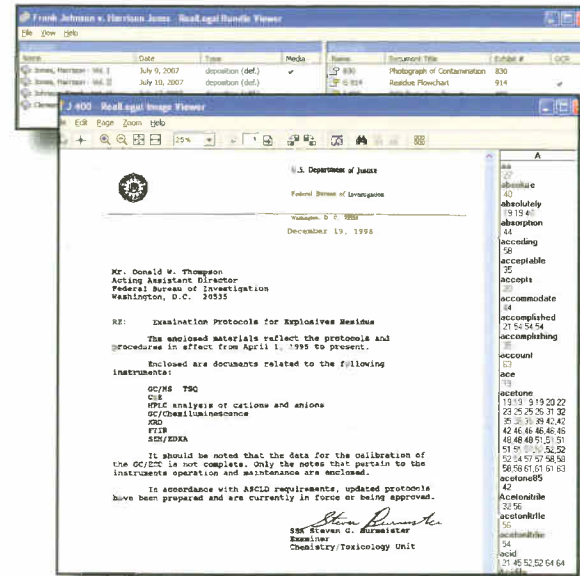

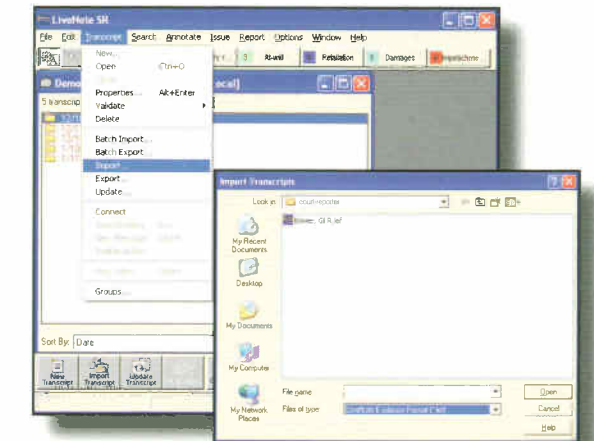
